### Bidding for a property

You have registered on the choice-based letting system (HomeseekerPlus), but I advise you to keep checking every week to see if there is a home on the system that you would like to move to. If so, please make sure you bid. If you are having problems with this please contact me and I will do my best to help you.

### Security

We want you to feel safe and secure as more customers move from their homes and more houses and flats become empty. Please can you make sure that the front and rear communal doors to the block of flats are closed and locked at all times so that other people cannot enter the block.
